### 4 février : Matthew King, « The Unjust King? The Great Fifth Dalai Lama's Advice to the Tüšiyetü Qan »

**Matthew King** (Professor of Buddhist Studies, University of California-Riverside) interviendra dans le cadre du Séminaire des études mongoles 2025 sur : « The Unjust King? The Great Fifth Dalai Lama's Advice to the Tüšiyetü Qan »

Abstract: In 1649, the Fifth Dalai Lama penned a letter to Tüšiyetü Qan Gombodorji, the father of the first Jebtsundamba Zanabazar and a Qalqa ruler who had become a devoted patron. In lines of verse titled *A Garland of Mutilala* (Tib. *Mu thi la'i 'phreng ba*), the Dalai Lama provided Gombodorji with a comprehensive program to fortify his temporal power whilst traversing the path to enlightenment. He did so according to the formal features of *subhāṣita* and *rājanīti*: well-spoken advice on the moral affairs of governance. This paper explores the remarkable departures of this letter from received tradition, in particular the moral nihilism it promotes in the matters of state craft and its transformation of the “Two Systems” of unified secular and Dharmic power (Tib. *lugs gnyis*; Mong. *qoyar yosu*) into an individuated program for self-making.

## **4-5 avril 2025: Conference “Caring for the Dead”**

Faculty CONFERENCE convened by Professors Jonathan BRACK, Sean HANRETTA, and Akin OGUNDIRAN on **“Caring for the Dead: Ancestor Veneration, Religious Encounters, and the State in the Mongol Empire and Africa”**—Friday and Saturday, April 4-5, 2025.

### Description of the workshop:

This unique workshop seeks to explore the merits of a comparative approach to the historical and archeological study of elite practices concerning the dead and their remains in the medieval African and Mongol imperial contexts, and consider their modern and contemporary resonances. In both cases, the veneration of the dead of key ancestral lines was central to the reproduction and reaffirmation of social cohesion, political power, and the accumulation of material wealth and social resources. The workshop will bring into conversation archeologists, bioarcheologists, historians, art historians, and religious studies experts, who broadly study burial practices, ancestor veneration, religious afterlives, and political formations in Africa and within Mongol Eurasia. While the workshop focuses on Africa and Mongol Eurasia during the period identified as “late medieval,” we are also interested in expanding our temporal perspective and considering ancestor worship, rituals, and the state during the 19<sup>th</sup> and 20<sup>th</sup> centuries in both Mongolia and Africa.

All currently living forms of local history-related oral tradition among the pastoral communities of Mongolia are non-professional in the sense that traditional society did not create targeted supporting activities to assist the transmission and learning of narratives of oral tradition within family or broader community life. The oral transmission of historical memory has been attributed to Inner Asian pastoralist societies based on analogies with other geographical regions, but this assumption has yet to be systematically verified. On the contrary, Mongolian pastoralist society is unique in creating its own written documentation, even as the local archives of many areas have been completely or partially lost.

Collectively speaking, the oral memory of Western Mongolia preserves a unique historical experience of sustenance and resilience in this mountainous, semi-arid steppe and semi-desert region — dominated by, but not limited to mobile pastoralism. These memories are at urgent risk of falling into oblivion. The current moment is indeed the last opportunity to record the complex oral tradition of selected communities and to describe its structure, internal processes of transmission, and current changes. These Inner Asian mobile pastoralists are facing far-reaching economic, social, and environmental changes, leading to intensive movement of people and information within hitherto geographically and administratively closed rural communities.

Based on this challenge and our ten year-long field research experience in Western Mongolia, in 2023 the Institute of Mongolian, Korean and Vietnamese Studies, Faculty of Arts, Masaryk University launched a five-year project “Changing Adaptive Strategies of Mobile Pastoralists in Mongolia: Dynamics in Community Histories and Movement Patterns Documented Through Oral Sources” (Czech Science Foundation, GM23-07108M), thanks to which a team of experts has been formed to study the adaptation strategies of mobile herders, mainly through the herders’ own oral memories. This project runs in synergy with the project “Evolutionary interferences of religion and governance in Inner Asia: Comparison of mutual impacts with tributary countries: Mongolia, Korea, Vietnam” led by Michal Schwarz, Ph.D. (Czech Science Foundation, GA23-06953S, 2023-2025).

The main objectives of the “Changing Adaptive Strategies of Mobile Pastoralists” project are:

1. To specify methods of gaining complex knowledge of currently living forms of localized, non-professional history-related oral tradition among Inner Asian mobile pastoralist communities.
2. To posit this oral tradition as a dynamic and living phenomenon — despite external endangerment and tendencies toward unification — and to propose non-invasive means of supporting the preservation of this living oral legacy.
3. To attain a better understanding of how local oral traditions relate to the formulation of identities of individual groups, their ties to certain territories, and their relations to larger political and national entities.
4. To verify the hypothesis that through the detailed systematic recording and visualizing of seasonal movements of mobile pastoralists, beginning from a micro-local level through orally remembered segments of the past, hitherto inaccessible chronological evidence of changes (or, in some cases, stability) in land use by mobile pastoralists can be attained. This evidence can serve as a key source for investigations concerning factors contributing to the current degradation of pastures.

The present conference will address issues of local history-related oral tradition as a hitherto neglected and hardly determinable, yet highly significant and frangible category of intangible cultural heritage. Our team members would like to present the current results of our attempts to describe the emic understanding of the concept of history by local communities, to define patterns in the transmission process of local oral tradition in Western Mongolia in the past, and finally, to assess its current state.

In our understanding, the concepts of oral history and oral tradition are separate yet closely interrelated and intertwined, requiring a parallel knowledge of accessible archive (and other forms of written) sources. We eagerly welcome researchers dealing with issues related to the local history of any region of Inner Asia, relations of local identities and landscape, sacred geography, oral cartography, microhistories, and genealogy to present their methodological approaches to the collection, sorting, processing and practical use of their materials from oral and archive sources.

We look forward to welcoming you in Brno.

In 2025, we celebrate the 90th anniversary of Professor György Kara's birth (1935–2022) and the 75th anniversary of the establishment of Hungarian-Mongolian diplomatic relations. We wish to contribute to these events by organizing the Fifth International Conference on Aspects of Mongolian Buddhism on 8–9 April 2025. The conference is organized by the Department of Mongolian and Inner Asian Studies and Research Centre for Mongolian Studies, ELTE Eötvös Loránd University with partner institutions from Hungary and Mongolia.

Following the success of the conferences “Mongolian Buddhism: Past, Present and Future” in 2015, “Mongolian Buddhism in Practice” in 2017, “Mongolian Buddhism: Tradition and Innovation” in 2019, “Mongolian Buddhism: Animals, Plants and Bioethics” in 2022, the fifth international conference is for scholars and monks to present their work on any aspect of the textual tradition of Mongolian Buddhism. This can cover history, philosophy, education, monasticism, rituals, folklore and folk religion, and any other fields related to Mongolian Buddhism's textual tradition preserved in written form or oral narratives.

The tradition of Mongolian Buddhism traces back centuries, and Buddhist teachings and practices exist in both written and oral forms. The aim of the conference is to reveal the wide diversity of Mongolian Buddhism's textual tradition. The conference will focus on the Buddhism of Mongols living in the present area of Mongolia and the beliefs and practices of Mongols living in China, Russia, or other places where Mongols settled. The distinctiveness of Mongolian Buddhism compared to the Buddhist corpus in general will be revealed through the presentations. The scientific papers will be published in book format.

Renowned Hungarian Orientalist, Mongolist and philologist, Professor György Kara (1935–2022), corresponding member of the Hungarian Academy of Sciences, head of the Department of Inner Asian Studies at ELTE Eötvös Loránd University and the Research Group for Altaic Studies of the Hungarian Academy of Sciences for decades, was a pioneer in the research of the “Books of the Mongolian Nomads” and laid an emphasis on different scripts, eminent polymaths, and philological research of Mongolian texts. Presentations concerning Professor György Kara's oeuvre, research topics, and philology are also warmly welcome.

The main languages of the conference are English, Mongolian and Russian.

The organizers will provide refreshments during the conference. Travelling and accommodation should be organized individually. If you need assistance regarding accommodation possibilities, please ask the organizers.

An escorted visit to the Oriental Collection of the Library and Information Centre of the Hungarian Academy of Sciences would be organized in the afternoon on 7 April 2025. The first day of the conference, 8 April 2025 will take place at ELTE Eötvös Loránd University, and Károli Gáspár University of the Reformed Church in Hungary will host the panels of the second day, 9 April 2025.



Cette publication réunit des travaux de chercheurs et chercheuses francophones et Anglophones travaillant sur les productions de missionnaires chrétiens entre 1830 et 1970 en diverses régions du monde (Asie, Afrique et Océanie). Dans une perspective d'anthropologie historique, les sources produites par les missionnaires sont approchées comme des données empiriques, porteuses à la fois d'un discours émiqque et de contextes intellectuels historiques. Ces sources permettent d'appliquer un regard réflexif sur l'histoire, qui passe par leur relecture critique. C'est dans l'optique d'abord de questionner le contexte et le contenu de ces productions missionnaires, puis de leur (re)donner une place dans le milieu scientifique que cette publication est envisagée. C'est aussi en tant qu'objet que ces sources, qui sont produites avec leurs propres attentes et contraintes, sont appréhendées. Les différentes contributions permettent de comprendre les perceptions missionnaires de terres considérées comme lointaines, de questionner le lien entre colonisation et mission et de porter un regard réflexif sur les sources produites en ces contextes.

## Call for papers

### Conference 'Justice' and 'Legality' in Imperial and Post-Imperial Spaces 1-3 May 2025

Venue: Ilia State University, Tbilisi, Georgia (to be confirmed)

Deadline for submission of applications: **31 January 2025**

The focus is on **Justice and Legality in Imperial and Post-Imperial Spaces**, with a geographical focus on **Eurasia/West Asia/South Asia**. See the call for details. The deadline for abstracts is **31 January**, and we hope to be able to confirm participation by the end of February.

The JUSTIMINO research group at ZMO is hosting a conference in Tbilisi, Georgia, in early May, and you are all welcome to circulate the call.

While there is no set definition of the 'rule of law', with over half a dozen indices competing for recognition and influence, many nineteenth and twentieth-century empires and post-imperial spaces would not score high on any of these. And yet, the notions of **legality and justice** greatly mattered in them. Political and cultural elites invoked these notions as much as ordinary people, with outcomes that could not be scripted. While existing literature has addressed legality and justice mostly in histories of intellectual opposition to authoritarian rule and in studies of state policy (focusing, for example, on imperial reform, or on 'socialist legality'), there is little recognition of how important and instrumental they both were to the struggles of **ethnic and religious minorities**. We understand 'minority' not primarily in numerical terms but following legal scholarship on 'minority protection', as an experience of being dominated by powerful 'Others'.

This conference seeks to track these struggles in the Russian Empire, the Soviet Union, its successor states and a range of adjacent regions (especially West Asia and South Asia). Non-Russians made up over half of the population in late imperial Russia (thus constituting a numerical majority, if taken together) and just under 50% of people in the Soviet Union. Whereas religion was one of the key determinants of rights, privileges, and obligations in the empire, 'nationality' understood in ethnic terms replaced religious affiliation in this capacity under socialism. Just as religion greatly affected access to places of residence, occupation, and education in the imperial period, nationality did so under Soviet rule – and in some cases continues to do so, albeit indirectly or covertly. Being part of a religious or ethnic community other than the dominant one could mean open or subtle forms of discrimination. Yet, such discrimination was neither automatic, nor did it go unchallenged.

This conference therefore explores the **ways in which ethnic and religious minorities**, from the mid-nineteenth century to the present, **invoked and employed 'legality' and 'justice' to further and enforce their rights**. It asks to what extent the political orders allowed, even encouraged, them to do so, even if the debate and activism thus invited could help to erode their authority. What is more, 'minorities' were also represented among the political and cultural elites, from imperial lawyers to party officials. Thus, the three-day conference looks at minority actors from both 'above' and 'below', as participants in policy-making and public debate, as judges and litigants, and as activists. What did non-dominant religious or national minorities expect when they called on 'justice' and 'legality' (or rather: 'injustice' and 'illegality')? More importantly, to which degree did this strategy help them defend their rights?

The research aims to answer questions that include (but are not limited to) the following:

- In what ways did elites and ordinary people understand and articulate the 'rule of law', 'legality' and 'justice' in their respective socio-political contexts?

- How did religious and ethnic minorities invoke justice and legality in their appeals to authority? What did they want, and what did they achieve?
- What did these diverse groups expect when navigating the constraints imposed by authoritarian regimes?

Please submit **your CV** and **abstract of up to 500 words**, including information on your research methodology, to **Maija.Susarina@zmo.de**. You will receive an acknowledgement of receipt and within 4 weeks, you will be informed about your participation in the conference. **The venue will be confirmed at the end of February** (please note that due to the current political situation in Georgia, the venue may have to be moved to another country in the region, such as Armenia or Turkey).

Some funding is available to cover the travel costs of applicants (transport, accommodation), with funding priority given to scholars from the region, and PhD students.

The conference papers are designed to be published in a special issue or edited volume, upon the necessary revisions, and should therefore not be under consideration for publication elsewhere.
